Proposal: Three additional Gypsy/Traveller pitches at an existing Gypsy and Traveller site,

each comprising 1 static home, parking for 2 vehicles and bin and cycle stores (retrospective)

Site: The Paddocks, Vickery Lane, Bentley, Farnham, Hampshire, GU10 5JU

Comments: Bentley Parish Council have considered this retrospective application for 3 additional pitches at the Paddocks and have the following comments to make. This application:

1. Makes no reference to the Bentley Neighbourhood Plan (2025) and any of the relevant policies;

2. Is contrary to our Bentley Neighbourhood Plan (2025), Policy BEN 1: Spatial Plan; given that this is therefore development in the countryside, we do acknowledge that some work has been done to ascertain the need for Gypsy and Traveller sites over the next 10-20 years, however this information is confusing and does not necessarily seem to support the case for this site e.g. "as at 31 March 2025, there is 1.8 years supply of deliverable land for Gypsy and Traveller pitches". We would like to see more clarity about the needs, specifically the needs in Bentley;
3. Acknowledges that the vast majority of the site is now hardstanding which seems at odds with our Bentley Neighbourhood Plan (2025), Policy BEN 12: Sustainable Drainage & Wastewater, including the following "A. All proposals for residential and commercial development will be supported provided they are able to demonstrate that they maximise natural sustainable drainage where appropriate, as well as including: permeable driveways and parking areas, and soakaways, to manage the risk of surface water flooding". We would like to see how this application can retrospectively comply with policy BEN12;

4. Is retrospective; we question why this is yet another retrospective application. In line with the vast majority of applications that we consider each year from the rest of the village, we would prefer that all future applications are submitted before the work is completed.

We would also like to see any work done by EHDC to ensure that this site complies with the original planning consent and consent for changes over the years.
